

ORDER

The Office of the Tennessee Attorney General and Reporter filed a Petition to Authorize Disclosure of Records on behalf of the Tennessee Emergency Management Agency ("TEMA") on March 22, 2017. This Court has reviewed the petition and related documents cited by TEMA in their request for guidance.

TEMA's petition requests a determination by this Court regarding whether certain records concerning the Chimney Top 2 and Cobbly Nob fires that occurred in November 2016 may be disclosed pursuant to a public records request cited in its petition.

After a review of the petition and supporting documentation, the Court notes that the order prohibiting disclosure of information cited by TEMA and entered by this Court on December 14, 2016, was intended only to address the actions of the parties to the causes of action currently pending before this Court. Specifically, the order was directed to the District Attorney General's Office for the Fourth Judicial District of Tennessee, the attorneys representing each of the



defendants, and all respective agents of the parties. This Court did not intend to direct or address the actions of any other entities or parties not specifically involved in these cases.

This Court does not have the information necessary or the authority to determine whether TEMA should provide the records requested as set forth in its petition. TEMA has not been ordered to provide nor precluded from providing any information pertaining to its duties under the Public Records Act. The Court, however, cautions TEMA that, under applicable law, the identity of any juveniles or information leading to disclosure of identity of juveniles detained by this Court shall not be released.
